1. Be it resolved that the NASSCAL membership establish a permanent position on the NASSCAL executive with the title "Independent Scholar Member." This would result in the following changes to the by-laws:

The term of office of the director elected and designated as Independent Scholar Member shall be two years, terminating at the bi-annual meeting of the Independent Scholar's final year;</p> <p>G. At the first annual meeting the members shall elect six (6) additional directors for a term of two (2) years, terminating at the bi-annual meeting of his or her final year;</p>
